

HVFCo holds annual Firefighters' Appreciation Banquet

Members of Haddam Volunteer Fire Company celebrated their 2018 achievements during the annual Firefighters' Appreciation Banquet held Feb. 2, at the Riverhouse at Goodspeed Station. Haddam Fire Chief Sam Baber emceed the event, which included a social hour with hors d'oeuvres, dinner, awards, recognition speeches, raffle prizes and a photo slide show. The banquet ended abruptly at 9:05 p.m., when many firefighters responded to the scene of a motor vehicle accident.

In 2018, three members completed Firefighter I; four members completed Firefighter II; four members completed EMR or EMT training; and one Junior completed Introductory to the Fire Service course at the Connecticut Fire Academy.

In 2018, Haddam Volunteer Fire Company responded to 581 calls for emergency services (106 more calls than in 2017) including 11 fires; 331 medicals; 72 motor vehicle accidents; 48 alarms; 30 elec-



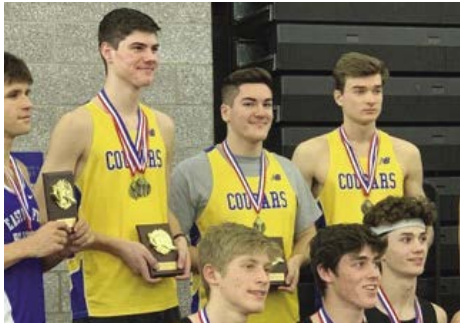
trical hazards; 11 hazmat; 7 marine; 11 good intent; and 48 others. Haddam received mutual aid on 24 of those calls and provided mutual aid 32 times. Members volunteered more than 2,500 hours of service, as well as countless hours of training.

Firefighter Mike Miller received the Firefighter

of the Year Award for going above and beyond in 2018. Miller, who is 62 years old, recently joined the company and completed Firefighter I and Firefighter II training. He serves on multiple committees and was praised for his positive and go-getter attitude. Lt. Tony Lafo received the Chief's Award for "wearing many hats" in the company. Lafo serves on the Haddam Volunteer Fire Department Board of Directors, leads the company's fit testing project, spearheads the Membership Committee, and serves as the company's record administrator. Lafo also was a 2018 top responder. Captain Ed Adametz, Ej Adametz, Joe Tomasso and Greg Duval received Star Awards for establishing and implementing the company's new Field Training Officer program.

The 2018 top responders were honored with a certificate. They are: Ej Adametz with 239 calls; Capt. Richard Zanelli with 220 calls; Lt. Tony Lafo with 189 calls; Capt. Peter Brown with 187 calls; and Ron-

In and Around The Haddams: February 1919 Local News

Selected from the pages of *The Evening Press* and lightly annotated by Sally Haase

Higganum, Feb. 1, 1919: It is very evident that the ladies of the Red Cross are becoming much interested in the work now being done for the suffering French and Belgians, by the large number present on Thursday.

Mrs. Chauncey Clark, Mrs. Howard Spencer, Mrs. Cornelius Kingsland, and Mrs. Walter Kingsland were pleasantly entertained Thursday at the home of Mrs. Jarvis Kingsland. A bountiful dinner was served, while the afternoon was pleasantly passed with graphophone selections.

East Haddam, Feb. 3, 1919: A consignment of twelve game fowl are being shipped from Whippoorwill Terrace to Scranton, Pa., this week.

The National Net and Twine Co. have rented the rooms across the street from the factory of W.O. Peck and will be fitted up into an office.

Hartford, Feb. 4, 1919: The Connecticut senate refused by a vote of 20 to 14 to pass the resolution ratifying the federal prohibition amendment to the constitution of the United States. This action means that regardless of what the admittedly "dry" house may do, that Connecticut will never ratify. [There was no need for Connecticut to ratify. On January 16, 1919, Nebraska became the 36th state and the last state needed to ratify the amendment.]

Senator Hazen of the 34th district, who voted in favor of the amendment, said that while the waste and misery of the war was awful, the waste and misery of the liquor traffic was worse. He said the question was not one of ratification of the amendment, but as to whether or not Connecticut would stand in line with 44 states which ratified the amendment. The question

was the greatest before the senate since abolition.

Senator Brooks, opposing the resolution, criticized the provision saying there would be about 50 different state laws. He said that returning soldiers were the maddest bunch he had ever seen when they heard of the passage of the law in their absence. Connecticut never did ratify the first twelve amendments to the federal constitution, he said, nor did they ratify the income tax amendment. [With ¾ of the states needed to ratify the Bill of Rights, Connecticut, Massachusetts and Virginia did not vote for the amendments. In 1939, Connecticut ceremoniously, voted to ratify. Connecticut voted NOT to ratify the XVI Amendment to levy and collect taxes, yet Connecticut voted for a state income tax in 1991.]

Moodus, Feb. 4, 1919: W.N. Manee has a large force of helpers at work filling

his ice house with nine-inch ice from Wigwam pound.

The delivery clerk at W. J. Thomas is using W.N. Manee's horse and wagon, until repairs are made to his automobile.

Middletown, Feb. 5, 1919: Merwyn Smith, alias "Red Eagle," an India, has been about town for nearly a month past, except a short sojourn at Haddam jail as the guest of Sheriff Thompson, will spend the 120 days at the jail as a result of his outbreak yesterday. Red Eagle has been a familiar sight on Main street

for some days past, wearing as he did a broad brimmed sombrero. He apparently is an Indian of some education and attended an Indian school as a boy. Yesterday he called at the hotel of Phillip O'Meara, the valley Hotel, and asked for a room. Some words followed and finally O'Meara called the police. When they got there, Red Eagle and the proprietor had nearly come to blows. Red Eagle fought and kicked the officers, but was restrained with

the help of bystanders. It was evident from his conduct that he had been taking too much whiskey.

Waterbury, Feb. 8, 1919: The proposed barge canal along the Naugatuck valley from Waterbury to tidewater at Derby may not materialize now as the result of a hearing today. It developed at the session that many of the factories along the route would object strenuously to the proposition if it interfered with their present waterpower. In addition, the costs of construction and the acquisition of water rights would be staggering.

Higganum, Feb. 10, 1919: The school in town is holding one Saturday session every two weeks to make up the time lost by the epidemic of influenza.

Hartford, Feb. 11, 1919: By a vote of 153 to 96 the Constitution house of representatives voted in favor of the federal ratification of the prohibition amendment which last week was rejected by the state senate [and thus failed.]

Coblenz, Germany, Feb. 15, 1919: Press heroes behind the scenes: Officers, chauffeurs and mechanics contributed to the harvesting of the news of what the Yanks were doing along the western front, although the part they played was not spectacular and might easily be overlooked. Mechanics toiled over cars plastered thick with

Cluster Headaches

These are known as "Histamine Headaches" and are primarily a neurovascular headache disorder, where the cause is not well understood, and as their name suggests come in groups over a period of weeks.

Typically, a patient experiences one to two cluster periods per year, lasting 2 weeks to 3 months. Cluster headaches are classified as episodic or chronic, based on whether the duration lasts less than a year or more than a year.

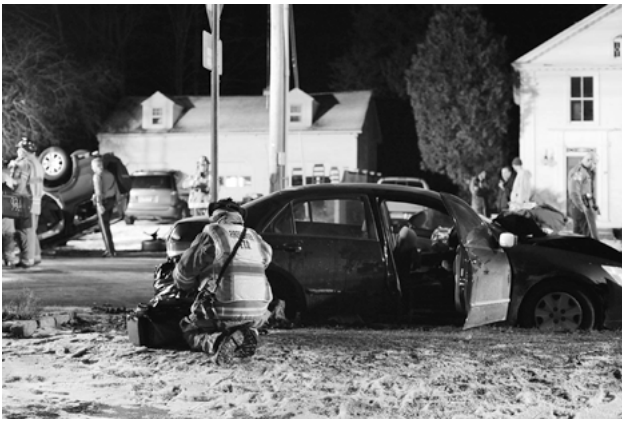
The patient with Cluster Headaches experiences attacks which are severe or very severe, strictly unilateral pain that lasts 15 minutes to 3 hours from once every other day to up to 8 times a day. These attacks are associated with nasal congestion, and runny nose. During cluster headache attacks, as many as 90% of patients become agitated and extremely restless, not likely to sit down, and instead will pace or move around.

Treatments:

- Triptans (sumatriptan, naratriptan, etc.) are often the first line treatment of cluster headaches and migraines, because they produce a direct vasoconstriction to stop the attack- they are approximately 70% effective.
- Calcium Channel Blockers may be most effective agents to prevent cluster headaches
- Deep Brain Stimulation is an option for cluster headaches unresponsive to medications.

Accident sends five to hospital

Five patients were transported to local hospitals following a motor vehicle accident Feb. 2, on Saybrook Road near the Jail Hill Road intersection.

At 9:05 p.m., Haddam Volunteer Fire Company and Chester Hose Company were dispatched to the scene where two vehicles collided. One vehicle was found on its roof with two occupants still inside. Fire Police immediately shut down a section of Saybrook Road and rerouted traffic.

Crews stabilized the vehicle and began to assess the occupants. Both were alert, with minor injuries. Firefighters used hydraulic tools to force open the vehicle's doors to extricate both occupants and they were transported to Middlesex Hospital.

Firefighters and EMS personnel also worked to rescue three occupants of the second vehicle. The driver of that vehicle had self-extricated and complained of minor injuries. He was evaluated and transported to Middlesex Hospital. The remaining occupants were extricated and transported to the hospital with minor injuries. Both vehicles were leaking fluids and absorbent materials were used to contain the spills.

Crews cleaned debris and New Image Auto LLC recovered and towed both vehicles; Saybrook Road was reopened.

Mutual Aid was provided by Chester Hose, Chester Ambulance, and Deep River Ambulance, as well as Hunters Ambulance and Haddam Volunteer Ambulance Service.

Watch out for signs of vaping in teens

Editors Note: Most of this information was part of a letter that went out to all parents of students at Haddam Killingworth Middle School on Feb. 5, 2019, so that people in the community know what to be on the lookout for, whether you're a grandparent, aunt, uncle, family friend, or neighbor:

We need a community approach to ensure that our children and families are well-educated about the dangers associated with vaping and smoking. Vaping devices have only been around for a few years, and yet we are seeing an increase in diseases that are directly attributable to use of ENDS (e.g., wet lung, smokers' cough, wounds that won't heal).

Electronic Nicotine Delivery Systems (ENDS) are designed to bring nicotine or THC oil (the substance in marijuana) into the blood quickly, without the tar or smoke traditionally associated with a cigarette or marijuana. However, they are not safer than cigarettes due to the nicotine and other chemicals that are inhaled through the vapor. They might be scented like cotton candy, pineapple, cherry, or other flavors that are appealing to young people. Just like

traditional cigarettes, it is illegal to sell them to children under the age of 18, and it is illegal for a minor to even "possess" electronic nicotine delivery systems or vapor products in Connecticut.

ENDS come in a variety of forms and often resemble everyday objects that would not necessarily cause you to suspect that your child may be using them. There are devices that look like USB drives, guitar picks, cell phones and pens, and others that look like cigarettes, pipes or cigars. They are easily accessible on Amazon.com or purchased locally.

This is a very timely topic considering that the latest statistics regarding teen tobacco and ENDS use were recently released by the Centers for Disease Control, and these statistics are startling. In Connecticut, 3.5% of high school students smoke traditional tobacco products and 14.7% use ENDS. Use of ENDS is now at epidemic proportions among teens and some students start their use of these products during their middle school years. In addition, the State of Connecticut spends \$0 and ranks 49th out of 50 in tobacco prevention spending despite bringing in \$500.8 million dollars in tobacco revenue. Comparatively, the Tobacco Industry spends \$73 million on marketing in the State of Connecticut alone, much of which is targeted at our children. "Published research studies have found that kids are twice as sensitive to tobacco advertising as adults and are more likely to be influenced to smoke by cigarette marketing than by peer pressure. One-third of underage experimentation with smoking is attributable to tobacco company advertising." (<https://www.tobaccofreekids.org/problem/toll-us/sources>)

Talk about it with teens you know. Make sure they understand the dangers to their health, and the possibility of addiction.

The legal aspect of vaping by minors was added by our editorial staff.

the grime of battlefields, day and night, in heat and cold, fair weather and foul, and they never grumbled. Chauffeurs went without sleep and meals. They drove through areas shelled and gassed. They carried their cars into machine gun range under the orders of the correspondent whose duties compelled visits to advancing lines. They drove without lights on nights as black as ink, during air raids and navigated through hazardous congestion of armies moving into battle. And yet in spite of the dangers and hard work, the chauffeurs had the most fascinating jobs in the army. The correspondents, in need of keeping close on the heels of developments, saw every nook and cranny of the battle areas, toured the British and French fronts, in addition to the American battle lines. There was no end to narrow escapes. The cou-

riers deserve a lion's share of praise also. They carried the news copy to the telegraph stations through mud and rain, sometimes riding all night.

East Haddam, Feb. 21, 1919: Marshall Miner is to discontinue his milk route and his sold his cows.

The ferryboat from Rocky Hill passed this place,

under steam, Tuesday. She is to run on the Chester-Hadlyme route while the "Cheslyme" undergoes repairs. It is quite unusual to see the river so clear of ice at this time of the year.

100 years ago, much has changed and, then again, nothing has changed.

Senator Needleman's utilities legislation

Senator Needleman's piece about his bill 'to hold Utilities Responsible' was recently published in this paper. It is feel-good legislation about which many consumers would approve but it does nothing to make Connecticut a better place to create jobs and make our state more likely to attract business and keep our residents from leaving our state.

However, I have recently heard in the media about a number of proposals which are being put forward which deserve the Senator's negative attention:

One proposal is a state car tax which would in effect take tax revenue that the towns depend upon and send that money to the state coffers. If the towns are deprived of the car taxes they will simply have to raise mill rates on real estate to make up the loss. In effect vehicle owners will be double taxed.

Another proposal will force small towns to regionalize their school systems. While regionalization is considered by some to be a benefit because of supposed cost savings which do not materialize it takes away from voters the ability to be in charge of their schools and further concentrates power over schools in boards which are less responsive to parents.

Tolls are simply another way for the state to increase revenue (i.e. tax us more) and then have no incentive to cut spending. No to tolls.

Increasing the sales tax to 6.85% or by any amount, taxing medicine and gro-

ceries are all incentives for more people to leave Connecticut. Our Senator should speak out against these proposals.

I understand that legislators propose such things and then say that these will never pass or will be modified in committee and that their legislation is just to get the conversation started.

Senator Needleman should consider proposing some bill to reduce spending in some specific area to start a conversation! One suggestion would be to cap retirement benefits to highly paid state employees.

This letter was sent to Tom Hogarty, and all of the Board of Education members on Jan. 31, 2019.

Dear Tom Hogarty, Chairman of Public Building Committee for Regional School District 17,

I have some SERIOUS concerns.

I remember a meeting when I raised concerns about the panel covers on the boilers. It was also a concern of Mike Distefano and Rob Albert at the time. There were only 2 boilers installed and the clearances of the

open doors was in question. You asked Doug "in your professional opinion, what do you think." He didn't give a professional opinion, just an opinion so he could move on with the boilers. You then looked at me and said, "if you feel strongly about it, we can take it up with the errors and omissions, at the end of the job, we need to finish this." WHAT DID THAT GET YOU? 6 wrongly installed boilers later.

Just before I resigned in disgust, I attended a job meeting in September at Central office in which you and Doug, and HT [Howard Thiery] and Joanne [Nesti] and Eileen Blewitt were in attendance with most of the sub contractors. When the disappointment about the solar panels came up, I listened to the problems Shea was having with the manufacturer. I then waited my turn and shared that you sent me the submittal sheet for the panels, I forwarded it to a man from Haddam (Jeff Lord) who was at the same time talking with the manufacturer at the International Solar Conference in Anaheim. We could have had those panels installed by now and before March/April, at best. No one has since contacted me to ask if it was a possible solution.

I hope that the rebates for the LED lighting is complete. These rebates change and it is the new year and a new Governor.

Accountability is what comes to mind. Who is accountable for these delays and mismanagement? and large change orders of well over \$100K for the boilers and the contractor has walked off the job, and a loss of electricity from the weeks on the roof? A

closed swimming pool and a cancelled swim meet for the students, while the Superintendent goes on a paid leave in Jordan when his building project is in total disarray. He is the ultimate overseer and everything eventually goes across his desk. Your comment about "Errors and omissions" only result in lawyer fees and extra costs. The HK coaches, Dick Dupuis, Sean Gallagher and Leah Pfrommer, want to congratulate the HK athletes for their hard earned success.


