Former First Selectman Schlag, 46, **Passes Away**

Melissa Schlag, former First Selectman of Haddam, passed away on Friday, October 2, 2020, at the age of 46, after a lengthy battle with cancer.

Back in 2011, Ms. Schlag gained the public's attention with her vocal opposition to the "Land Swap" in Haddam (17 acres of state land overlooking the river). On that wave, she ran for State Senator on the Green Party ticket in 2012, but

Ms. Schlag ran for First Selectman of Haddam in 2013, and served from November 2013 to November 2015. She also served as a Selectman from November 2017 to November 2019. Ms. Schlag received national attention when she started kneeling during recitation of the Pledge of Allegiance at Board of Selectmen meetings in July of 2018.

Spooky Stories from the Garden

In honor of Halloween, I thought I'd share some of the creepier experiences I've had in my gardens. No ghosts or witches, but a few chills up the spine, maybe.

The classic murder mystery. We've all seen at least one movie in which the bad guy maneuvers an inconvenient corpse into a wheelbarrow (the wheels always squeak), and then trundles it out to the back garden, where he buries it under cover of darkness. I'm here to tell you that's just plain boneheaded. Even out here in the country, most of us have neighbors who would notice that much activity in the middle of the night. Instead, whenever you have a body to dispose of, dig the grave in broad daylight, as non-chalantly as possible. That's what I did.

No, not really. But I DID dig a two-foot by six-foot trench for roses in front of my barn, on a corner lot open to two busy streets. Only then did I realize it looked just like a grave, but all the people driving by just smiled and waved. I waved back. Nothing to see here, folks. Just a little, er, composting.

What the Realtor never told you. What if it wasn't you, but a previous owner, who left sinister surprises in the garden? My predecessor at the same house had been a champion slob, leaving several dumpsters' worth of trash, half-obscured by waist-high grass. (Not to mention the pizza slices still in the microwave...in a house that had been empty for

over a year.) Directly behind the kitchen door was a pile of half-burnt chicken and rabbit bones. My first thought was that he practiced voodoo, but later I found cages in one of the barns, so apparently the rites were culinary in nature.

Weirdly, he had paved over most of the back yard, so it was only after bringing in a backhoe that I could even begin to prepare my long-awaited perennial beds. Classic murder mystery number 2, in which the body has been secreted under a slab of concrete or asphalt, right? My friends and I joked about it as I began to dig. But, six buckets of broken glass later, my shovel hit...something. I moved the shovel a few inches, and then a few more, as we do when trying to gauge to size of a rock. The "something" seemed to be about eight inches round. Knobby. Irregular. And as I moved the shovel, I began to glimpse of white through the dirt. Truly, I was spooked.

For just a few moments, I was Miss Marple. But, of course, it wasn't a skull, but something gardeners are far more likely to find in soil: the ghost of chemicals past, applied by a predecessor. Mine, fortunately, was benign: a half-empty bag of lime, rained on long ago and hardened rock-solid. (Or bone-solid.) And that's as close as I ever want to come to a Superfund environmental contamination site.

The sci-fi horror. My weirdest, freakiest garden experience happened here in Haddam, and while the previous stories might have been just flights of imag-

ination, this one is, unfortunately, all too real.

Soon after buying the house, I put down cardboard and wood chips for new garden beds, leaving it all to break down over the winter. When spring came, I went out back and sank a fork into the now-softened and enriched soil. As soon as the fork hit the ground, I was surrounded by large pink-brown worms levitating up from the chips, rising six or eight inches straight up before slowly dropping back to earth. Startled, repulsed, and spooked, I jumped back. I'd never seen anything like it.

But they're real. Crazy snake worms, jumping worms—they have many names, none of which quite capture the sheer revolting quality of these big, invasive creepy crawlies. Our part of North America has no native earthworms, as the glaciers scraped them all away along with most of our topsoil. The worms we're familiar with are all European imports. But the crazy snake worms are newer, different, and bad news. When touched, they explode into seizure-like writhing. Grab one by the tail end, and it breaks off, while the worm escapes. The soil they infest is recognizable by its coffee-grounds texture, stripped of nutrients, and as their population grows, more and more of the forest floor is depleted of its ability to sustain healthy undergrowth. This is a real-life Halloween trick, with, as yet, no treat. If the biologists come up with a way to eradicate these pests, I'll share it with you.

Really, I'd rather have a bucket of gummi worms.

PURA Extends COVID-19 Payment Program

Connecticut's Public Utilities Regulatory Authority (PURA) today issued a ruling that will extend the enrollment period for the COVID-19 Payment Program for non-residential customers through November 1, 2020. The enrollment period for the COVID-19 Payment Program for both residential and non-residential customers will now extend through November 1, 2020.

PURA also reminds all residential customers that the "Shut-off Moratorium" (https://portal.ct.gov/pura/consumer-services/pura-covid-actions) currently in place for state-regulated electric, gas and water utilities is scheduled to conclude on September 30, 2020. PURA encourages all customers experiencing difficulty paying their utility bills to contact

their utility company and to ask:

First, whether the customer is eligible to be "coded hardship." Special financial assistance programs are available to hardship customers. For more information, see https://operationfuel.org/2020/09/02/shutoffs/

Second, if ineligible for hardship status, to be placed on a COVID-19 Payment Plan.

Important Dates:

The Shut-off Moratorium for non-hardship residential customers is scheduled to conclude on September 30, 2020.

Enrollment for the COVID-19 Payment Program for non-residential and residential customers is open until November 1, 2020.

COVID-19 Payment Plans:

- Are available to any customer requesting financial cial assistance, without demonstrating financial need;
- Require no initial or down payment;
- Can be up to twenty-four (24) months in length;
- Waive any fees or interest in the calculation of the monthly payment amount;
- Facilitate the repayment of the past due balances in addition to the customer's current monthly bill.
- Importantly, any customer enrolled in a COVID-19 Payment Program who is current with their payment terms cannot be disconnected even once the Shut-off Moratoriums have concluded.

Connecticut Halloween Guidance

Sent out by Town of Haddam

The ongoing COVID-19 pandemic requires all of us to take steps to keep ourselves, our families, and our communities safe and healthy: wear our masks, wash our hands frequently, and maintain social distancing. As a result, we will need to celebrate many fall traditions differently this year, including Halloween. Traditional Halloween activities carry a high risk for spreading COVID-19, but we can reduce that risk significantly by organizing and participating in fun, lower or moderate risk alternatives. The holiday may look different this year, but the Connecticut Department of Public Health (CT DPH) believes we can

still enjoy a happy (and healthy) Halloween.

The CT DPH recommends that everyone planning to participate in Halloween activities this year review the guidance recently issued by the Centers for Disease Control and Prevention (CDC). That guidance (https://www.cdc.gov/coronavirus/2019-ncov/daily-life-coping/holidays.html#halloween) describes "lower" "moderate" and "higher" risk activities. DPH recommends that Connecticut residents avoid higher risk Halloween traditions and focus celebrations on the lower and moderate risk activities.

The ability to maintain social distancing and follow face covering rules is especially important when participating in Halloween activities. In addition, please refrain from leaving your home for any Halloween activity and do not pass out Halloween candy if you are ill or have traveled to one of the states listed on the Connecticut travel advisory (https://portal.ct.gov/Coronavirus/travel) between October 16th and October 30th (i.e. 14 days before Halloween). In this case you should be following the testing and self-quarantining guidelines, per Executive Order No. 9C. CDC guidance and safety tips are summarized below, along with additional considerations for restaurants and colleges and Universities.

intimate partners who are married, living together, or dating." (Source: 2018-2020 GFWC Club Manual: Signature Program: Domestic Violence Awareness and Prevention)

The Connecticut Coalition Against Domestic Violence (CCADV) defines Domestic violence as "a pattern of coercive, controlling behavior that can include physical abuse, emotional or psychological abuse, sexual abuse or financial abuse." (Source: www.ctcadv.org)

The CCADV (www.ctcadv.org) supports our state in preventing domestic violence. They report serving 37,773 individuals victimized by domestic violence who sought assistance through their 18 member organizations last program year, yet more cases of domestic violence in Connecticut go unreported. The CCADV member organization for Middlesex County is New Horizons Domestic Violence Services in Middletown (www.newhorizonsdv.com) which serves over 1000 individuals over a year, and is an organization the KWO has supported with donations for years.

One of KWO's most active committees is the Domestic Violence Awareness & Prevention Committee (DVAP). KWO's efforts include bringing awareness of the problem, its impact on the community and ways to help through events, panels and various other means. Some of their past efforts included:

Organized a workshop on domestic violence for

local residents.

- Worked with a local acting group to put on a docudrama at the high school about a girl assaulted on a college campus.
- Reached out to the Haddam-Killingworth schools to offer our assistance in their implementing Erin's Law, a law to provide education to all age school children in preventing sexual abuse.

Various donation drives to collect items for women and children who are living in a safe house overseen by New Horizons in Middletown has been a main DVAP activity. The drives include collection of holiday presents, welcome bags for new residents, pajamas for women and children, new mattresses for the shelter, and other needed items for the shelter. For two years, around the holidays, KWO donated home furnishing items to women who had been victims of domestic violence but had survived and were ready to move to their own homes. In 2018, KWO had an event celebrating women with 130 women attending and 20 female vendors – proceeds went to New

Horizons and other DVAP projects.

The DVAP Committee is looking for new projects and new members to join the committee. KWO's parent organization, the General Federation of Women's Clubs (GFWC), has expanded their interest beyond intimate partner abuse to violence against women in all forms: elder abuse, teen dating violence, campus sexual assault, violence against women of color, and child abuse, as well as to engaging men to promote respectful behavior and help prevent relationship abuse (Source: 2018-2020 GFWC Club Manual: Signature Program: Domestic Violence Awareness and Prevention). 

Killingworth Scouts BSA Troop #18 has gained another Eagle Scout. Jackson Pitts, a Senior at Haddam Killingworth High School, completed his Eagle project, a gaga pit, last summer/fall, but his Board of Review was postponed because of COVID-19.

To earn the rank of Eagle Scout, a Scout must earn 21 merit badges, 13 of which are "Eagle required" (such as First Aid, Personal Fitness, Citizenship in the World), plus eight more merit badges of their own choosing. They are also required to manage an Eagle project, which requires planning, managing work crews, and often raising funds and having to interface with an organization or town to get permission to do the project.

While involved with Scouts, Jackson participated in the troop's annual 50 mile hike on Vermont's Long Trail, along with a 100 mile canoe trip in Maine. He held the leadership position of Senior Patrol Leader, as well as patrol leader.

Jackson earned his Eagle Scout rank, as well as one Palm (this is achieved by earning an extra five merit badges — for each Palm — beyond the ones required for Eagle Scout rank).

Jackson's project was building a gaga pit at the Erik W. Auer Killingworth Recreational Park (KRP). For those not familiar with the game of "gaga," it is

played in a wooden structure with a ball, sort of like soccer where you get other players "out" by making the ball touch them below the knee until there is only one player left.

"The physical construction of the project only took three weekends," explained Jackson," but the difficult part of the project was organizing the design, approval, and execution process. There were a lot of town meetings involved and many different people from whom I had to gain input, approval and support, along with getting the fundraising required to pay for the materials."

Jackson is busy outside of Scouts as well. He throws for HKHS Track & Field, and plays on the HKHS Football team (which was canceled this year due to COVID). He loves the outdoors, including biking, hiking, boating, swimming, and riding his dirt bike. And he is restoring his 1989 Ford truck, including swapping out the engine by himself.

"I witnessed Jack, first hand, turn from a young boy into a man as a result of this [Eagle] project," said Paul Pitts, Jackson's father and Scoutmaster. "It kick-started the next phase of his life, building the request, communication, planning and project skills to set him up for the future."

Because of COVID-19, his Eagle ceremony has been postponed. Congratulations Jackson!


